MEMORANDUM

Clarifications regarding execution of developmental works / projects of RD / Panchayat Department schemes up to Rs.5.00 Lakh have been sought by some Panchayat Samitis and Block Advisory Committees (BACs).

2. As per provisions of sub-section 1(a) & (b) of section 93 of the "Tripura Panchayats Act 1993", the Panchayat Samitis are empowered to execute works / projects along with other provisions. As per memo issued vide No.F.3 (1-6)-GEN/PR/02(i)/2809-909, Dated-25<sup>th</sup> May, 2006, the BAC shall perform the same functions mutatis mutandis as performed by the Panchayat Samity under Tripura Panchayats Act 1993 in areas outside the TTAADC.

3. It is clarified that Panchayat Samiti & BAC can execute works / projects up to Rs.5.00 lakh departmentally by assigning to TA/JE of RD department placed in Blocks or in Sub-Division as per equitable distribution done by BDO. GPs / VCs / PS / BAC should assign work to BDO / AE of sub-division who will allocate work to specific Implementing Officer according to existing work load. R.D. Engineering wing will prepare the estimates and give technical sanctions as per the latest SoR.

4. Technical Assistants (TAs) of MGNREGS posted at the Block office will be the Implementing Officer in case of construction works excluding hydraulic structures and the concerned Sub-Divisional Officer (SDO) of R.D. Department will be the supervising officer. Funds for construction of any hydraulic structure should be placed to the concerned Executive Engineer, RD for implementation through tenders.

5. The major materials for works shall be lifted from the RD store as per existing system according to availability. The other materials including materials not available in RD store shall be procured by the Implementing Officers as per approved rate finalized by the concerned RD Division / BDOs for the Block.

6. Plantation related works should be implemented through the concerned line departments. In case of maintenance work of small nature limited to a GP / VC the concerned Secretary-in-charge of the GP/VC or the Work Assistant of the concerned Block will be the Implementing Officer and concerned JE/TA of the Block will be Supervising Officer.

7. This is issued as per the approval of authority conferred vide U.O. No.333/Secy/RD(Panch)/2021, dated-6<sup>th</sup> September, 2021.
