



## MEMORANDUM


In continuation of the comprehensive guidelines issued for utilization of XV FC grants vide No.F.2 (12-98)-PE/PR/2020/15,136-17,697, Dated-25<sup>th</sup> September, 2020, the Tied grants of the XV FC can also be utilized for the following purposes:-

- i) For creation and maintenance of roof rain water harvesting structures and ground water recharge systems in Panchayats / Traditional local bodies / Government owned / controlled / aided schools during the Jal Shakti Abhiyan Campaign with theme "Catch the rain, where it falls, when it falls" from 22<sup>nd</sup> March, 2021 to 30<sup>th</sup> November, 2021.
- ii) For creation of nurseries to take up tree plantations during monsoon period in such schools.
- iii) Rural schools need to give special focus **on regular testing and tracking for the pandemic cases, as also intensive preventive measures viz. regular daily sanitation in schools, cleaning of school toilets** and proper arrangement in schools for hand-wash, wearing of masks and adequate social distancing. This may be ensured with **active cooperation of Education and Panchayat functionaries and convergence of funds available with the Education Department and Gram Panchayats / Village Committees.**
