Subject: Release of incentive grant under "Incentivization of Panchayats" Scheme to Panchayats awarded under Deen Dayal Upadhyay Panchayat Sashaktikaran Puraskar (DDUPSP) 2020 (Appraisal Year 2018-19).

Sir,

In continuation of this Ministry's sanction order of even number dated 28.10.2020 (copy enclosed), I am directed to convey the sanction of the President to the balance payment of Rs.1,00,00,000/- (Rupees One crore only) to the State Government of **Tripura** as an incentive grant under "Incentivization of Panchayats" Scheme for the Deen Dayal Upadhyay Panchayat Sashaktikaran Puraskar (DDUPSP) 2020 (Appraisal year 2018-19). The amount may be transferred to the Panchayats as per **Annexure** on account of their having been adjudged as the best Panchayats in the State.

2. The payment will be released by RTGS drawn in favour of RD (Panchayat) Department, Govt. of Tripura, State Bank of India, TLA House Branch, Colonel Chowmuhani, Agartala, Account No. 32409516286 (IFSC Code SBIN0005559).

3. The expenditure is debitable to the following Head of Account:

Demand No. 71, (2020-21)

- 2515 - Other Rural Development Programme (Major Head)
- 00.101 - Panchayati Raj (Minor Head)
- 33 - Rashtriya Gram Swaraj Abhiyan (RGSA)
- 02 - Incentivization of Panchayats
- 33.02.31 - Grants-in-aid General

4. The amount will be transferred by the State to the Panchayats mentioned in **Annexure** within 15 days from the date of transfer to the bank account of State. The State will be liable to pay penal interest @ RBI Repo rate in case the award money is not transferred to Panchayats within 15 days from the receipt of funds.
5. The State concerned will furnish a UC (in GFR 12-C) indicating transfer of incentive amount to awardee Panchayats within 15 days. The State will ensure proper utilization of award money by the Panchayats concerned. **The award money will be utilized for public purposes especially for livelihood support, asset creation, civic amenities creation & maintenance and bridging the gaps in the funds received from Union/State Government for various projects.**
6. It is certified that no UC, which has become due, is pending with the State Government.
7. The accounts of the Grantee Institution shall be open to inspection by sanctioning authorities and audit, both by the (i) Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and (ii) internal audit by Pr. Accounts Office functioning under Chief Controller of Accounts of this Ministry, whenever the Institution is called upon to do so.
8. This issues under the delegated powers of the Ministry and with the concurrence of the Integrated Finance Division vide their Diary No. 248/IFD/MoPR/2020-21 dated 25.03.2021.
