**MEMORANDUM**

The Gram Panchayats / Traditional Local Bodies (TLBs) are mandated to prepare their Gram Panchayat Development Plans (GPDPs) for the year 2022-23 in campaign mode from 2<sup>nd</sup> of October 2021 to 31<sup>st</sup> January 2022.

Since the grants under XV FC are transferred to the District Panchayats (Zilla Parishad, TTAADC, HQ) & Block Panchayats (Panchayat Samiti, BACs), it is imperative that utmost attention may be made while creating Panchayat Development Plans for these two tiers of Panchayats.

The separate credentials for District and Block Panchayats has been created for both GPDP portal ([www.gpdp.nic.in](http://www.gpdp.nic.in)) and eGramSwaraj application. Also, a functionality to enable delegation of activities from higher to lower tier panchayats and vice versa has been provisioned in eGramSwaraj application. Planning exercise may be taken up while keeping such supportive functionalities in mind.

It is requested that planning exercise may not be restricted to an individual level, it may rather be a convergent effort, where in Block Panchayats may utilise GPDPs and District Panchayats may utilise BPDPs for holistic planning. A timeline for creation and upload of GPDPs, BPDPs and DPDPs is as under:-

Sl No	Activity	Timeline
1.	Final GPDP upload for all GPs / VCs in eGS	31 <sup>st</sup> January 2022
2.	Final BPDPs upload in eGS by converging / analysing GPDPs created	31 <sup>st</sup> March 2022
3.	Final DPDPs upload in eGS by converging BPDPs	30 <sup>th</sup> April 2022

The following steps may be followed to ensure collective and holistic planning exercise for preparation of Block and District Panchayats Plans:-

i) All District and Block Panchayats to schedule separate Zilla Sabhas, wherein ward members, district / block standing committee members should take an active part.

ii) Consolidated GPDPs & BPDPs may be discussed in these meetings.

iii) Frontline workers / officials from other Line Ministries may also attend Zilla Sabhas.

iv) XV FC, State FC (PDF), MGNREGS and other flagship schemes of central / state department may also be discussed.

v) Consolidated form of Mission Antyodaya critical gaps may be prepared at both District and Block levels, and planning should focus on uplifting laggard sectors.


