NOTIFICATION

As per the provision laid down in the Revamped Rashtriya Gram Swaraj Abhiyan, for saturating the Capacity Building of the stakeholders of local bodies, the institutional strengthening at the block level needs to be ensured and the community/meeting hall available at the block level shall be treated as **Block Panchayat Resource Centre** which will facilitate the capacity building programme at the block level from now onwards.

The BPRCs shall have to ensure the following facilities-

- a. Well-decorated hall with sufficient seating arrangements inside the hall.
- b. Laptop/PC with UPS, Web Cam.
- c. Wi-Fi facility.
- d. Projector with projector screen.
- e. Sound/PA system.
- f. Drinking water facilities.
- g. White Writing Board.
- h. AC Machine.
- i. Smart TV.
- j. Dais and Podium.
- k. Glow Sign Board.
- 1. Fire Fighting arrangements, etc.

The expenditures in this regard shall be taken up by using the fund to be placed under Revamped RGSA as well as by using available funds lying with the concerned Panchayat Samity/Block Advisory Committee under Share of Taxes (PDF), Administrative portion of XVth FC United Grants, Own Source and any other permissible sources.

The fund is to be placed @ Rs. 4,20,000/- under the Revamped RGSA Scheme to all Blocks and the said fund needs to be incurred by 15th August 2024 positively.

It is a fact that at a time all the required items may not be ensured but all the above mentioned items have to be ensured by 2025 without any fail; in order to monitor proper compliance of the items in the BPRC, the strict vigil will be made from this end; under any circumstances said fund can not be utilized for any other purpose and if it is detected that any Block does not require the fund as will be placed from this end for the development of BPRC or having either all facilities or on arranging all, the unspent amount may be surrendered.

The detailed guideline for utilizing the fund to be placed under the Revamped RGSA Scheme is enclosed herewith for reference.

Guidelines for utilizing the fund to be placed under the Revamped RGSA Scheme

The fund placed for the development of Block Panchayat Resource Centre under the Revamped Rashtriya Gram Swaraj Abhiyan Scheme can be implemented for the following-

- a. Hall Maintenance of the BPRC.
- b. Interior decoration works in the hall.
- c. Purchase of Laptop/PC with UPS, and Web Cam.
- d. Arrangements of Wi-Fi internet facility inside the hall.
- e. Purchase of Projector with projector screen.
- f. Procurement of chairs, and tables for seating arrangements inside the hall.
- g. Permanent arrangements of Sound/PA system.
- h. Arrangements of drinking water facilities preferably installation of water purifier.
- i. Arrangements of White Writing Board.
- j. Installation of Air Conditioner Machine in the hall room.
- k. Installation of Smart TV not above 55 inches in the hall room.
- 1. Development of Sitting Dais and Podium.

All the expenditures shall have to be made by following all the codal formalities.
